Minutes of the meeting of School Fees Fixation Committee held on 10 Jan 2022

The school fee fixation committee meeting was held on 10 January 2022. This meeting was presided over by the Assistant Director of St. Xavier's Chain of School, Bilaspur region. Nodal officer Mrs. Usha Chandra, the representative members of the School Fee Fixation Committee (SFFC), School Principal, Vice Principal, Head Mistress were present in the virtual meeting.

1. The SFFC meeting started with the welcome address of the Principal of the school, Mrs. Supriya AP.
2. The meeting was held virtually via Google meet in view of the current third wave of the pandemic. She briefed about the smooth functioning of the school in the year 2021-22 and the acceptance and support of the entire parent fraternity. She further added that the same support is expected in the future too.
3. The old fee structure was presented before the committee and she explained the necessity of hike of 5% at least to meet the increasing expenses.
4. All the members agreed upon the proposed hike and the new fee structure for 2022-23 with 5% hike in fee was approved by all the members.
5. Further it was informed to all the members that viewing the financial crisis of many parents during pandemic, school management was collecting the approved fee of the session: 2020-21 during session 2021-22 giving some relaxation to the parents.
